

**TOWN OF ST. CROIX FALLS
STOP SIGN PLACEMENT ORDINANCE
ORDINANCE NO. 11-04**

SECTION I - PURPOSE

The purpose of this ordinance is to identify placement of stop signs on town highways within the Town of St. Croix Falls.

SECTION II - AUTHORITY

The Town Board of the Town of St. Croix Falls, Polk County, Wisconsin, has the specific authority under s. [349.07\(8\)](#), Wis. stats., and general authority under its village powers under s. [60.22](#), Wis. stats., to adopt this ordinance.

SECTION III - ADOPTION OF ORDINANCE

This ordinance, adopted by a majority of the town board on a roll call vote with a quorum present and voting and proper notice having been given, provides for the installation of stop signs on town highways at the intersection of through highways in the town.

Stop signs shall be placed on :

Northpoint Road	at the entrance to	140 th Avenue
Hungerford Point	at the entrance to	140 th Avenue
Sunset View Drive	at the entrance to	US Highway 8
Deer Lake Park	at the entrance to	US Highway 8

The town chairperson, or his or her designee, shall erect and maintain stop signs as provided in this ordinance on or before the effective date of this ordinance.

SECTION XII - EFFECTIVE DATE

This ordinance is effective on publication or posting.

The town clerk shall properly post or publish this ordinance as required under s. [60.80](#), Wis. stats.
