ORDINANCE No. 06-02
DESIGNATING CERTAIN TOWN ROADS
IN THE TOWN OF ST. CROIX FALLS
AS “CLASS B’ HIGHWAYS

The Town Board of the Town of St. Croix Falls, Polk County, Wisconsin, does hereby ordain as follows:

SECTION I. - GENERAL PURPOSE

The purpose of this ordinance is to ensure the safety of the individuals living within the town and those individuals who use the town roads, by preventing frequent travel of large vehicles on the town roads other than for regular delivery within the town.

SECTION II. - ADOPTION OF STATE STATUTE

Chapters 348 and 349 Wisconsin Statute 2005-2006, and any amendments thereto including words and definition; enforcement provisions, and penalties, are hereby adopted.

SECTION III. - AUTHORITY

The Town Board of the Town of St. Croix Falls has specific statutory authority under Wis. Stats. 349.16 to impose weight limitations on highways within its jurisdiction to protect the constructional integrity and the safety of those individuals using the town roads.

SECTION IV. – DESIGNATION OF ROADS

The Town Board of the Town of St. Croix Falls, hereby designates the following town roads in the Town of St. Croix Falls, Polk County, Wisconsin, as “Class B” highways:

120th Avenue: those segments thereof maintained by the Town of St. Croix Falls

122nd Avenue

123rd Avenue

125th Avenue

140th Avenue

150th Avenue: all segments

160th Avenue: including those segments maintained by the Village of Centuria

165th Avenue: the segment maintained by the Town of St. Croix Falls

170th Avenue: including those segments maintained by the Village of Centuria

180th Avenue: those segments thereof maintained by the Town of St. Croix Falls

Anderson Avenue

Dans Avenue

Lees Avenue

Peer Avenue

Summit Avenue

Fairgrounds Road: all segments

Poplar Lane

River Road: (North) from State Road 87 to Eureka townline

180th Street: those segments thereof maintained by the Town of St. Croix Falls

190th Street: those segments thereof maintained by the Town of St. Croix Falls

200th Street: including those segments maintained by the Village of Centuria and including the those portions lying entirely within the Village of Centuria

207th Street

208th Street: those segments thereof maintained by the Town of St. Croix Falls

210th Street

212th Street: all segments

220th Street: those segments thereof maintained by the Town of St. Croix Falls

235th Street

Leo Street

Leonards Street

Neils Street

Nyberg Street

Sunshine Street

Traprock Drive

SECTION V. – PENALTY PROVISIONS

Any person who shall violate any of the provisions of this ordinance shall, upon conviction of such violation, be subject to a penalty, pursuant to Wisconsin Statute.

SECTION VI. – ENFORCEMENT

In addition to those police and traffic officers designated in Section 349.02 Wis. Stat. 2005-2006, the Town Board may by resolution designate such other person or persons to enforce this ordinance.
